**Georgia Charitable Solicitations Act  
 Paid Solicitor Registration  
 Paid Solicitor Bond**

KNOW ALL MEN BY THESE PRESENTS:

as surety, are held and firmly bound unto the Secretary of State of the State of Georgia, for the use of the State of Georgia, and to any person who may have a cause of action against the Principal for any malfeasance or misfeasance in the conduct or solicitation by the Principal as a Paid Solicitor, in the sum of \$10,000.00, lawful money of the United States of America, to be paid to the Secretary of State of the State of Georgia for the use of the State of Georgia and to any person who may have a cause of action against the Principal for any malfeasance or misfeasance in the conduct of solicitation by the Principal as a Paid Solicitor, as their interests may appear, not exceeding in the aggregate the said sum of \$10,000.00 for which payment well and truly to be made we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally by these presents, in accordance with the terms, limitations and conditions set forth in O.C.G.A. § 43-17-4.

WHEREAS, the above bounden Principal has applied to the Secretary of State of the State of Georgia for registration as a Paid Solicitor for the purpose of acting as a Paid Solicitor for a charitable organization required to register with the Secretary of State of the State of Georgia pursuant to O.C.G.A. § 43-17-1 et seq. (Charitable Solicitations Act of 1988) (hereinafter "Act").

NOW, the condition of this obligation is such, that if the Secretary of State of the State of Georgia shall register the above bounden Principal as such Paid Solicitor and said Principal shall faithfully and honestly act as such Paid solicitor in accordance with law, and fully comply with the provisions of the Act, and the acts amendatory thereof and supplemental thereto, and if the Principal shall fully indemnify and save harmless from loss the State of Georgia and any person who may have a cause of action against the Principal for any malfeasance of misfeasance in the conduct of solicitation as such Paid Solicitor then this obligation shall be void, otherwise to remain in full force and virtue.

This bond shall not become void upon the first recovery thereon but may be sued upon from time to time until the full amount thereof shall have been exhausted. This bond is to cover all claims arising on account of the registration of the Principal and his acting as such Paid Solicitor for the full
