David Maschke recused himself from discussion and abstained from the vote on this complaint.

- ARCH120004 Forward to Enforcement for further investigation into possible evidence of unlicensed practice

The Board received correspondence regarding the use of the title “Architect”. Anne Smith, Board Chair for the Georgia State Board of Architects and Interior Designers, also serves as the NCARB Regional Chair. Chairperson Smith updated the Board regarding changes to continuing education requirements, rule changes and upcoming conferences.

Laurie McRae led discussion surrounding NCIDQ dues payments, the cost to individual state boards, the advantages of being dues paying members and NCIDQ'S review process.

David Maschke updated Board members regarding his committee's Board Outreach Project, presented at the 2011 BOAG conference in Atlanta, Georgia. The committee created a PowerPoint presentation which gives an overview of the Georgia Law and Board Rules for Architects and Interior Designers. The presentation has been accepted by AIA (The American Institute of Architects) for continuing education credit.
