

**GEORGIA STATE BOARD OF DISPENSING OPTICIANS
BOARD MEETING MINUTES
November 19, 2008**

Mr. Morris established that a quorum was present and called the meeting to order at 10:07 a.m.

CORRESPONDENCE

Correspondence received reviewed, discussed and a response was provided to the following individual by the Board:

Kirkland A. McGhee – Concern presented: Opticians Association of Georgia (OAG) would like to raise its concerns regarding the Georgia State Board of Dispensing Opticians (“Board”) intent to pass a rule change that would permit all continuing education credits to be obtained online.

Board Response: Board Rule 420-9-.01, amended 02-19-2008, states “no more than two (2) hours may be obtained via the internet”. **Mr. Meldrum moved, Ms. Drake seconded, and the Board voted to allow the Administrative Staff to respond back to the correspondent as directed. None opposed, motion carried.**

Sharon Riggle – Concern presented: Housebill 241. I am not apposed to the bill itself, but the 30-day timeline you have placed on it.

Board Response – The minimal time frame incorporated into the statue was unfortunate but it is now law. Any amendments to the Georgia law can only be considered by the Legislature. **Ms. Drake moved, Mr. Meldrum seconded, and the Board voted to allow the Administrative Staff to respond back to the correspondent as directed. None opposed, motion carried.**
